


Glendale Districting

2026, four-year term: Districts 4 (Asatryan), 6 (Brotman & Najarian) and any one of 1 (vacant), 2 (vacant) or 5 (vacant)
2026, two-year term: any one of 1 (vacant), 2 (vacant) or 5 (vacant)
2028: Districts 3 (Kassakhian & Devine), the 2026 two-year-term District, and the one of Districts 1 (vacant), 2 (vacant) or 5 (vacant) that did not elect in 2026.
