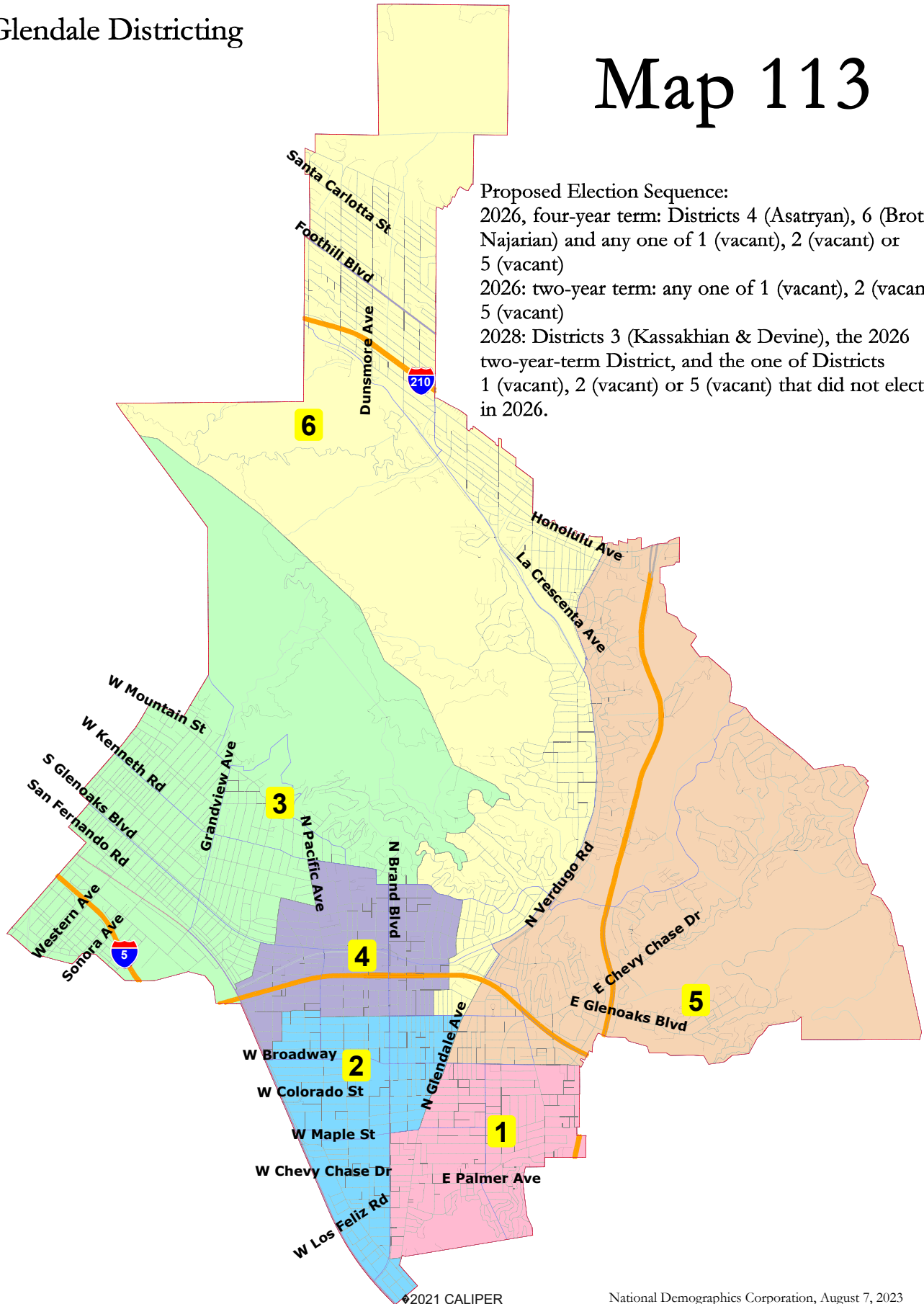


Glendale Districting

2028: Districts 3 (Kassakhian & Devine), the 2026 two-year-term District, and the one of Districts 1 (vacant), 2 (vacant) or 5 (vacant) that did not elect in 2026.
