

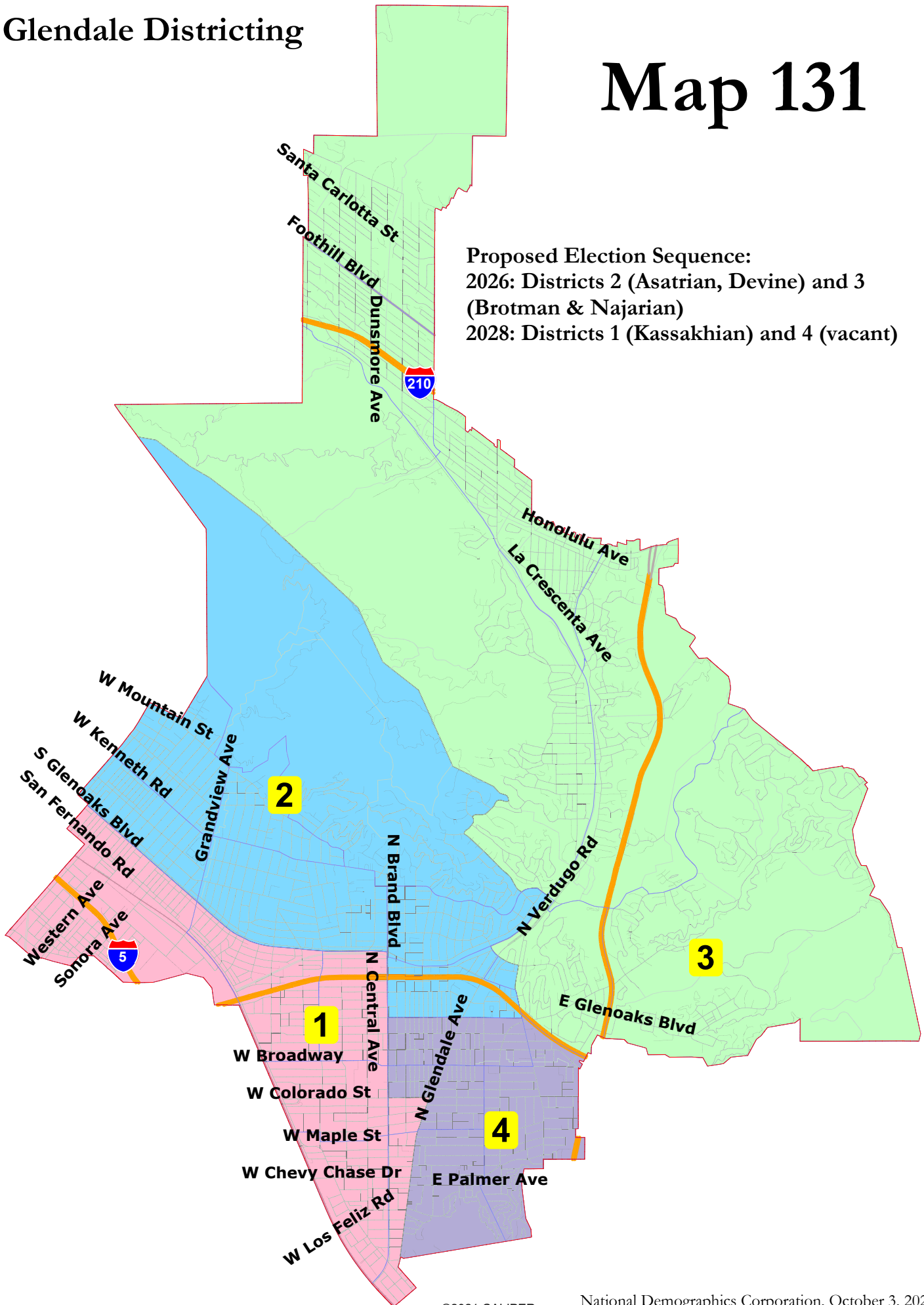
Glendale Districting
